SINCE 2003, BEN'S BELLS VOLUNTEERS HAVE BEEN PRODUCING THOUSANDS OF CERAMIC WIND CHIMES IN THE STUDIOS EACH YEAR TO DISTRIBUTE THROUGHOUT THE COMMUNITY. THE BELLS ARE A SYMBOL OF KINDNESS AND ITS POWER IN HEALING, MEANT TO TOUCH OTHERS LIVES AND MAKE OUR COMMUNITY A GENTLER PLACE TO LIVE.

THE STUDIO LOCATIONS ALSO OPERATE AS STORE FRONTS IN ADDITION TO AN ONLINE WEBSITE WHERE MERCHANDISE CAN BE ORDERED. SHOP KIND IS MORE THAN JUST A RETAIL STORE, HOWEVER. BEN'S BELLS' "GOODS FOR KINDNESS" ARE LITERALLY THAT. IT'S PURPOSE-DRIVEN SHOPPING THAT IMPACTS THE ENTIRE
